- b)** Ensuring integrative teaching of Ayurveda principles with a focus on evidence-based practices.
- c)** Organizing workshops, seminars, and training programs to enhance quality awareness among faculty, students, and administrative staff.
- d)** Monitoring adherence to clinical protocols, including Panchakarma, Shalyatantra, and Kayachikitsa procedures, as per QCI standards.
- e)** Facilitating regular audits of teaching schedules, clinical practices, and research activities to identify gaps and ensure continuous improvement.
- f)** Promoting hands-on clinical and research training for students and faculty to align with QCI's emphasis on practical exposure.
- g)** Overseeing the implementation of feedback mechanisms for students, faculty, and allied stakeholders to drive improvements.

- h) Coordinating preparation and submission of documentation required for QCI accreditation audits.
- i) Organizing field visits to Ayurveda pharmaceutical units, medicinal gardens, and clinical centres to enhance practical learning.
- j) Promoting interdisciplinary research and collaboration for the advancement of Ayurveda science and practice.

Instructions for the Committee:

- a) The Chairperson shall convene IQAC meetings at least once every quarter, with emergency meetings as required.
- b) The minutes of the meetings shall be recorded and submitted to the undersigned for review and compliance.
- c) The IQAC shall ensure timely implementation of quality improvement initiatives in alignment with QCI requirements.
- d) This Committee shall come into effect from 19th December 2025 and remain operational for the academic year 2025-2026.
